Minutes of the Meeting of Hilldale Parish Council

Thursday 30th April 2020; 7.00pm by electronic communication under the provisions of Section 78 of the Coronavirus Act 2020

1. Apologies: Cllr May Blake

Welcome: The Chair welcomed all to the meeting.

- 2. Declarations of Interest and Dispensations: None declared.
- **3. Minutes of the Previous Meeting 9 March 2020:** These were agreed as a correct record; proposed by Cllr D Whittington and seconded by Cllr I Bell; and will be duly signed by the Chairman.
- 4. Matters arising from the Previous Minutes: None
- **5. Update on Covid 19 response:** The website was duly updated following Government advise on Covid 19; posters displayed at the village hall and on the adjoining field reminding people about social distancing; the police closed the village hall car park. It was confirmed that the furlough scheme was not applicable to Parish Council employees. The Chairman spoke of the successful work which 30 volunteers had undertaken throughout the village. The Clerk advised that she had e mailed Kath Westby regarding the hall's loss of income and any potential funding available.

Three issues have been raised via e mail from members of the public.

Speeding - the Chairman confirmed this is an ongoing problem and suggested individuals who witness the offence need to report to the police. When restrictions ease (Covid 19) it may possible to utilise Parbold speed equipment.

Dog Fouling - Signage is already placed around the village. The Clerk suggested the use of spraying the pavement (image previously circulated) which is used by a neighbouring borough and has been very effective in deterring dog mess. However, it was felt that the issue is dog fouling on the field and bags not being placed in bins rather than dog fouling on pavements.

Planning Application, 19 Chorley Road

(APPLICATION NUMBER: 2020/0297/FUL) A text message had been received by the Chairman from a member of the public regarding concerns relating to a planning application to erect 2 detached 3-bedroom houses at the location of 19 Chorley Road. Concerns were raised specifically in relation to the highways safety issues this

presents in relation to the proposed vehicle access to the properties from Robin Lane, in particular the proximity of the access to the Chorley Road/Robin Lane junction and the use of the junction by HGV's. In addition, a very narrow pavement exists which could hamper pedestrians. It was agreed that the Clerk would write to Councillor Iddon highlighting this and requesting a site visit to fully appreciate the impact this development would have.
