Chairmans Column

Last week I attended the funeral of Terry McMahon, a Hilldale resident of 50 plus years.



Terry and his late wife Maureen had been very supportive of how the Parish Council had developed Hilldale playing field over the years and after the service, talk inevitably turned to our recent communication regarding the Village Plan and the potential for any further residential development in the village.

It became clear to me that in some quarters, there had been a misunderstanding or misinterpretation of the message we were trying to convey.

The results from the survey are shown in this newsletter, but for clarification I feel that I should reiterate the position of the Parish Council in these matters.

The Parish Council has a duty to present residents with all potential scenarios, good or not so good and respond to the wishes of those who reside in Hilldale.

The Parish Council does not support any development of the green belt, or conservation areas. The example of CIL money, was one scenario if development occurred over the next 10 to 15 years. Under no circumstances would the Parish Council support residential development, purely to access this type of funding.

The purpose of the survey was to ask residents how they would like to see their village develop over the next two decades, which will allow the Parish Council to facilitate this vision, to the best of their ability. It will also offer a blue print for future Parish Councils to follow.

All members of the Parish Council give their time voluntarily, they do not receive any renumeration nor do they claim any expenses.

<u>Grant Success</u> - We are delighted to be announce our Parish Clerk, Trish has been successful in 3 recent grant applications to support our Parish. One in relation to a speed indicator device, with two further grants agreed in principle for improvements to the village hall. Further details in our next newsletter.

Speed Indicator Device - The funding application submitted to West Lancashire Borough Council (which has been match funded by the Parish Council) is for the purchase of a speed indicator device (SpID). Speeding traffic and road safety is a regular concern raised by residents in the village. The SpID will remind drivers of the speed limit by standing out from normal signs which could help to break the habit of drivers who consistently use excessive speed. The improvement of road safety for the village will educate and inform drivers about their speed thereby reducing the number of road traffic collisions. Data collected from the SpID will be available to the highways authority to be used to better target any relevant enforcement activities.

We are currently liaising with Lancashire County Council as to best location(s) for the SpID in order to target hot spot areas. As we are purchasing a solar powered portable devise, we intend to move it about to give a consistent message throughout the village.

<u>Junior Play Area</u> - You will have noticed that unfortunately we have reluctantly removed the junior multi activity play area. This was due to a safety inspection which identified issues with the timber structure that were beyond reasonable repair. We are actively exploring grant funding sources to replace in order to provide the children in the village an accessible and suitable play area in a safe inclusive and active environment. However, with an estimated cost of up to £40,000 (£10,000 of this for the play surface) this is a huge ask. If anyone has any good ideas or can assist in anyway with sponsorship, we'd love to hear from you.

We were very pleased to welcome pupils and teachers on site from Parbold Douglas Church of England Academy school and Our Lady's and All Saints Catholic school who provided us with their ideas for future play equipment including drawings which we intend to display in the village hall. Richard Durnings Endowed Primary school are also actively involved in collating ideas.

<u>Field in Trust</u> - As you may be aware the playing field has 'Field in Trust' status which we were fortunate to obtain 11 years ago.

As such whilst the ownership and maintenance lie with the Parish Council, we are duty bound to comply with the strict conditions of this dedicated space. That is; it must be used in the manner for the purpose for which it was intended – a public playing field and recreation ground.



With this in mind we wish to remind everyone that planting on the field is not permitted unless this is part of a project agreed by the Parish Council.

<u>Village Plan</u> - At the beginning of the year, we began work to revise the existing Village Plan, which has been in existence for the past 20 years. The village plan is a way for communities to have their say in the places which they live and work. It gives the power to produce a plan with real legal weight that directs development in your village.

We issued a survey to all residents which discussed the issue of the potential for further residential development, priorities, concerns and ideas for future change which will improve the quality of life in the Parish of Hilldale. We received 48 responses in total and have detailed a summary of the results below.
